## PSO meeting and Speaker 23 April 2025

The next PSO meeting will be held via Zoom at 10am on 23 April. We again are lucky enough to have an outside speaker joining us. Christine Jones is the Learning and Development Manager for Safeguarding Adults, Cambridgeshire County Council. One of her main responsibilities is to ensure our Social Work practitioners are supported to carry out efficient and effective section 42 enquiries using the legislative, statutory and local guidance guidelines.

Christine will give a short talk around exploring confidential information sharing, the importance of consent and what this means in relation to safeguarding adults, capacity, defining when an adult would be deemed an adult without care and support needs and what would be Cambridgeshire County Council Adult Social Care, responsibilities would be in these situations.

#### New Member of the Safeguarding Team

We are very pleased to be able to welcome Jacqueline Jugg to our Team and will let her introduce herself to you.

"I joined the team as an Assistant Diocesan Safeguarding Advisor on 5th March 2025. My working hours are



Wednesdays, Thursdays, and Fridays from 9 am to 5 pm. I am a retired Cambridgeshire Police Detective, having retired in March 2020 after 30 years of service. Throughout my career, I specialised in safeguarding roles, including investigating allegations of child abuse, serious sexual offences, and the protection of vulnerable adults. I also hold a Police Trainers Certificate and spent five years training officers in these areas, as well as interviewing vulnerable victims and witnesses and performing family liaison roles. I concluded my service by managing registered sex offenders in the community. After retiring, I



worked on a self-employed basis for Embrace Child Victims of Crime, a national charity based in Peterborough. At Embrace, I developed and delivered safeguarding training and served as one of three designated safeguarding officers"

## Evensong and Bishop's Garden Party 11 June 2025

We look forward to seeing you at this year's garden party for Parish Safeguarding Officers and their guests. The Garden Party will be held in the Bishop of Ely's Garden following the Evensong service on Wednesday, 11 June at 5:30 pm. ### **Duty Phone, Parish Website** and Notice Board Posters

Please check that your parish website and noticeboard posters display the correct information for raising safeguarding concerns or making referrals to the Safeguarding Team. We have noticed that some websites list either Sarah King or Rebecca Boswell's emails and telephone numbers. Please note that Sarah does not handle this area of work, and Rebecca no longer works for the diocese. The following text can be used on your websites:

#### **Making Safeguarding Referrals**

Please call the Safeguarding Duty Messaging Service: 01353 652747

- When making a referral by calling the Safeguarding Duty Messaging Service, please leave a message with your name, telephone number, and a brief explanation of the reason for your call. The team member on duty will be alerted to your message and will call you back to discuss your safeguarding referral, offering professional advice and support, and together with you, agree on a plan to manage the next steps.
- In a safeguarding emergency, please contact the Police on 999.
- Out of hours: To report a safeguarding concern when the Diocesan Office is closed, or when Diocesan Safeguarding Team members are unavailable, you can call the Safeguarding Duty Telephone Number: 01353 652747, which will forward your call to our partners at the 'thirtyone:eight' Helpline. Let them know that you are calling from the Diocese of Ely. (Please note that the Helpline is not available between Midnight and 7:00 am.)

Your notice board posters should only display the Duty phone number rather than individual Safeguarding Team members. The Promoting a Safer Church poster already has this number printed on it. We can send copies of this poster to you if you need to update it.

Please note that Rebecca's email address has now been closed, so please do not use it in the future as you risk your email not being answered.
